Introduction

Navigator Nutrition BV (hereinafter referred to as "**Navigator Nutrition**", "we," "us," "our") makes use of cookies and similar technologies, such as JavaScript, tracking pixels and beacons, (hereinafter collectively referred to as "**cookies**") on its website www.navigatornutrition.nl, including sub-pages (hereinafter referred to as "**Websites**").

This Cookie Statement applies when you visit our Websites. In this Cookie Statement, we explain to you what cookies are and how we use cookies on our Websites.

1. What are cookies and how are they placed?

A cookie is a small file that stores certain information on your access device (PC, tablet, smartphone, etc.) when you visit our Websites. When our Websites are accessed by the user's device, the server can evaluate the information stored in the cookie in various ways.

Navigator Nutrition, as the Website administrator, may place cookies on your device. These cookies are also referred to as 'first party cookies'. However, cookies may also be placed by third parties, such as advertisers and/or parties who place cookies to analyze the use of our Websites. These cookies are also referred to as 'third party cookies'.

Navigator Nutrition uses both temporary session cookies, which are deleted at the end of the browser session, and permanent cookies, which remain present on the device used to access the user for a certain pre-set period of time.

2. Why does Navigator Nutrition use cookies?

We use cookies for a variety of purposes, including:

- To obtain information about your visits to our Websites;
- For remembering your preference settings;
- To simplify your searches;

- To keep track of the number of visitors of our Websites and how they use the Websites, to make our Websites function efficiently, and to better understand our visitors;
- To analyze and resolve technical and organizational problems related to our Websites (troubleshooting);
- To provide advertising, communications and content from us and third parties on our Websites and third-party sites;
- To allow you to share content from our Websites on your social media accounts, such as Facebook, LinkedIn or Instagram.

3. What types of cookies does Navigator Nutrition use on its Websites?

Navigator Nutrition uses **functional cookies** on its Websites to help make our Websites function optimally. For example, the Website adjusts to the size of your screen and these cookies allow you to navigate the Website more easily.

We also use **basic analytical cookies**, i.e. analytical cookies that have no or limited impact on your privacy. These cookies are used to map the use and functioning of our Website and (based on that) to improve the Website.

Pursuant to the Telecommunications Act, the placement of functional and basic analytical cookie types does not require the Website visitor's consent. However, when you visit our Website, we do inform you about the placement of these cookies by means of the cookie banner that appears on the screen at the bottom of the web page.

We also use **analytical cookies** to monitor interaction with our Websites. For example, these cookies allow us to map visitor locations and analyze the impact of our advertising campaigns. We use your location only with your consent.

Navigator Nutrition also uses **tracking cookies**, which provide a record of the usage history of visitors to our Website. Tracking cookies are active, for example, when we place ads on third-party websites and apps.

4. How can I enable, disable or delete cookies?

Session cookies are automatically deleted as soon as you close your web browser. For permanent cookies, you can withdraw your consent at any time via the <u>cookie banner</u> or by adjusting your browser settings. Information regarding enabling, disabling and deleting permanent cookies can be found in the instructions and/or using the Help function of your browser.

5. Does Navigator Nutrition process personal data through cookies?

The use of cookies often involves the collection of personal data. To obtain information about the personal data we collect through cookies and how we use this personal data, please see our <u>Privacy Statement</u>. In our Privacy Statement, we also explain how and why we collect and use your personal data and what rights you can exercise in connection with the processing of your personal data.
